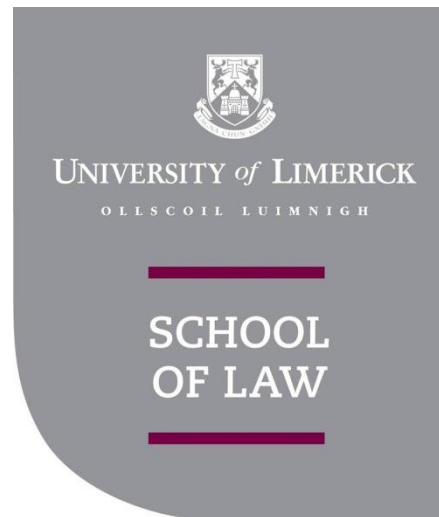

If Law Plus students undertake Study Abroad in the 2nd semester of 3rd year, results obtained will count for academic credit. Law & Accounting students may only undertake Study Abroad in the 2nd semester of 3rd year and may only do so with the consent of the Co-Operative Education Division and the Course Director.
